What data do we collect?

StriData BV. collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Company identification information (Company name, company address, phone number, etc.)

How do we collect your data?

You directly provide StriData BV. with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

StriData BV. collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.

When StriData BV. processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

StriData BV. securely stores your data at WordPress.com. StriData will keep your data for the period during which it's relevant. Once this time period has expired, we will delete your data.

You have the right at any time to stop StriData BV. from contacting you for marketing purposes. If you no longer wish to be contacted for marketing purposes, please contact us at info@stridata.com

What are your data protection rights?

StriData BV. would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request StriData BV. for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that StriData BV. correct any information you believe is inaccurate. You also have the right to request StriData BV. to complete the information you believe is incomplete.

The right to erasure – You have the right to request that StriData BV. erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that StriData BV. restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to StriData BV. processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that StriData BV. transfer the data that we have collected to another organization, or directly to you, under certain conditions.

- **Advertising** – StriData BV. uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.
